<u>Public Comment:</u> Ms. Lynne Ann Walsh, Ann Street, commented on the noise ordinance and how it needs to be changed. She stated how the decibel level method we have right now is insufficient and would like to suggest enforcement of the violation with fines for repeated violations. Ms. Walsh also stated that the audible level at 125ft, is actually very generous. It's more than most municipalities. Based on her research, if a noise at the property line is at 80 decibels you're not supposed to be able to hear it more than 100ft away.
