MILFORD BOROUGH – MEETING MINUTES 3/20/23

The Milford Borough Council met March 20, 2023 at 7PM in the Borough Hall located at 109 W. Catharine Street for a regular council meeting. This meeting was advertised and open to the public. Milford Enhancement Committee Report: The bids were opened for the West Hartford project. The initial grant for that was \$500,000. That was the initial estimates. The low bid was \$700,000, so we were \$200,000 over our grant. However, through some work with the PennDOT, we were able to find additional monies through PennDOT. So right now, PennDOT is covering the \$700,000 for the project with a reserve of \$70,000 from the Milford Enhancement Committee. In the event that we have any cost overruns that are necessary, keep in mind the \$700,000 already has a 15% cost overrun expectation in it, so we're in a good shape. Expectation is that we're going to move forward and continue with the project. Motion to accept the MEC report - Thatcher/Manion, AIF.

<u>Shade Tree Report:</u> Shade Tree committee just finished taking down 13 trees on Friday, and we're going to be planting 13 new trees that we've received a grant for from the state of Pennsylvania. Those will be planted in the first week of April on the Borough designated Arbor Day. Bills will be going out to residents for eleven tree removals. Four of the trees are Milford Borough Park trees. **Motion to accept the Shade Tree report – Thatcher/Farrell, AIF**

Treasurer's Report: February P&L Reports still have a negative balance at the end of the month but it has significantly decreased from a negative \$44,004 to a negative \$620. The Borough has been receiving real estate tax payments, collected to date is \$14,445. Real Estate Transfer tax to date is \$10,344, EIT received to date is \$93,268, after commissions and fees. Delinquent money collected for 2021 totals \$531 for February. The Borough is still receiving money from anyone that hasn't paid yet in 2021. The LST tax to date has reached \$11,363. For Liquid fuels, we are set to receive \$41,425.82 in March. Tomorrow the auditors are coming to complete the 2022 audit. We are actually a whole month and a half ahead from last year's audit completion. Hopefully we'll have a completed audit by the April meeting for review. The MPD is going to look into how they can stop these tractor trailers to ensure they are making a local delivery and within the 4 tons weight in accordance with the Borough Ordinance.
