MILFORD BOROUGH - MEETING MINUTES 4/17/23

The Milford Borough Council met April 17, 2023, at 7PM in the Borough Hall located at 109 W. Catharine Street for a regular council meeting. This meeting was advertised and open to the public. Present were Council President Joseph Dooley, Council Members Peter Cooney, Andrew Jorgenson, George Lutfy, Doug Manion. Also present were Solicitor Jason Ohliger, Mayor Sean Strub and Secretary/Treasurer Francesca Lombardo. The meeting was called to order followed by roll call and the Pledge of Allegiance.

Milford FD/EMS-First Quarter 2023 report —The MFD has added 17 new members in 2022 and 2 more in the first quarter of 2023. Between the MFD and EMS, they had over 4000-man hours of training in 2022 and 500 hours of training in the first quarter of 2023. The MFD also received a grant to purchase a UTV, which is an off-road vehicle that will allow the MFD to do more environmental type rescues. The First Quarter Report is posted on the Borough Website.

Zoning Report: Zoning/Building report for the month of March reviewed as provided.

SEO Report:

a. SEO Services – Customer Informational Packet – This packet is posted on the Borough website. **Milford Enhancement Committee Report:** Spring Cleanup Day is this Saturday, April 22nd. **Shade Tree Report:** Tuesday, 4/18, the Shade Tree Commission is planting 13 new trees throughout the Borough.

<u>Treasurer's Report:</u> The Borough has collected through March \$164,383 in real estate tax and real estate transfer tax in the amount of \$11,199. The audit for 2022 is completed, and the DCED report has been filed. The auditor's report showed that there were no findings and the financials were deemed to be in compliance in all material respects. All of our operating funds on deposit at NBT have been transferred to the IntraFi account, which now provides 4% interest, which may increase to 4.25%. All other funds on deposit with NBT were originally going to be earning 2.25% interest but we were informed that these accounts will now be earning 3.0%. **Motion to accept the Treasurer's Report, Manion/Lutfy, AIF.**

- b. ACT 537 Plan Administrative Completeness Review finalized (DEP-3/29/23) All of the resubmitted materials satisfy the comments made. A full technical review of the plan will be conducted and any comments generated will be communicated in future correspondence.
- c. Special Events Policy Update-Discussion and Vote to advertise ordinance change A few more changes in language need to be made for a better clarification of what type of special events are allowed to take place in the Borough.
- **d. Employee Handbook update status** The employee handbook is still being revised with more modifications to be presented at the next Council meeting.
- **e. Update on Interested Party status re LVL application Milford Twp** The Borough Council has engaged attorney Matt Galasso to represent us as an interested party with respect to the enhanced traffic portion in the LVL application for Milford Township.
- f. 2023 paving needs update President Dooley and DPW Supervisor, Paul Curran met with Jeff Roback of PennDOT to go through the 2023 paving needs. The spreadsheet that was circulated before to the Council showing the A's, and the A minuses on that spreadsheet listing the most important streets/alleys to be paved. Jeff and Paul then went around town and measured all locations to be paved. Jeff Roback is going to be preparing bid documents for us to review. We can modify those bid documents at that time before we send them out to bid. Jeff Roback also advised, even after the bids comes back you can modify the paving list.
- g. Discuss options for the Milford Borough Office Renovations The main focus of the Borough Office renovations were the cupola repairs on the roof of the building. We've gotten an offer from a local engineer to assist us with that, and he would charge us \$12,000 for the engineering work to assist us. The consensus amongst the Council is that we can do this on our own and do not need an engineer's assistance.

Mayor's Report: Police vehicle mileage was consistent with what it's been the last few years. Our citations and stops were down in March primarily because of the weather. We've had a number of meetings to focus on trying to get a grip on the problem with the trucks. The MPD Chief, Assistant Chief, Officer Carvounis and Mayor Stub had a meeting with Sergeant Youngblood and a few other Troopers explaining more about what we could and what we couldn't do. Sergeant Youngblood said if we pull over a suspected truck, we can hold them an hour to let the Troopers come with the portable weights and certified personnel to be able to fully investigate the truck. The MPD is going to send full-time officers, DaSilva & Pinzone as well as Officer Carvounis for full truck inspection training. The part-time Officer who is being recommended for hire already has truck inspection training. The MPD has been successful with two truck stops that resulted in citations.

Committee Reports:

Law/Zoning-Property – Our Zoning Officer & Code Enforcement Officer are distributing door hanger warnings as part of our quality-of-life ordinance. Some of the things we see around town, we're giving warnings after which there is a fee schedule if those violations are not addressed. SFM is putting together some sample noise ordinances for the Council and MPD Chief to review. This ordinance is going to allow the police to enforce violations on the spot.

Communications Technology: Doug Manion is working on getting bids for enhanced virtual

participation for meetings and working on the identification cards for employees.

Alex Garcia-Osuna, Catharine Street, had a question regarding the slide at the Ann Street Park, and when it was going to be fixed. He was advised we are going to order a new bottom piece to the slide that was damaged and it hopefully should be repaired soon.

Dennis Klein, a non-Borough resident, discussed the voluntary nature of Federal Income taxes and advised Council they should not approve an Earned Income Tax.
